APPLICATION FOR COMMERCIAL DOOR-TO-DOOR SOLICITATION PERMIT

1. Permits will be issued upon approval by the Chief of Police or his designee. Permits may be denied for good cause, including but not limited to, providing false or misleading information upon application or criminal record.
2. Permits will be valid for calendar month in which they are approved and will expire at midnight on the last day of that month.
3. Each member of a commercial entity who will be going door-to-door shall have a current permit, shall have it in his/her possession when soliciting, and shall present it to any police officer or resident upon request.
4. Each person permitted shall provide valid identification upon application.
5. Documentation of the commercial enterprise shall be provided upon application.
6. A fee of \$25.00 for each permit issued or reissued shall be levied.
7. The Police Department reserves the right to conduct an investigation as to the suitability of any applicant. Such investigations may include the acquisition of any governmental or law enforcement records pertaining to the applicant. A permit will not be issued until the investigation is complete.
